STIPULATION

In compliance with the Court’s orders of February 26 and March 3, 2020, the candidate and the objectors, by and through counsel, stipulate to the following:

1. The nomination petition of Greg S. Hayes contained 429 lines of signatures
2. Of those lines, 227 lines were unchallenged.
3. 202 lines of petitions were specifically challenged by Objectors. The challenge grounds were designated on the spreadsheet filed as Exhibit C to the Objection Petition.
4. Following a meet and confer session on March 7, the parties reached a partial stipulation as to signature lines.
5. The parties have agreed that an additional 25 lines were valid, for a total of 252 lines that were unchallenged or are, after review, valid by stipulation.
6. The parties have agreed that 103 lines are stricken as invalid.
7. An additional 74 lines remain in dispute, with the parties unable to agree on the validity of such line.
8. Attached is a modification of the spreadsheet which, in addition to identifying the challenge grounds initially identified, also identify whether the line is Stricken by Stipulation (S/S) or Valid by Stipulation (V/S).
